There was discussion about whether to hold Board of Directors elections at this meeting. A Motion was made Ray Santangelo, seconded by Jeff Robinson and passed (16-0) to delay the elections until the Annual meeting to held in the Spring 2009.

Tom Johnson did a presentation on eurasian milfoil which included handouts and information by the DNR.

There was a discussion about applying for a grant from the Wisconsin DNR to monitor and educate Red Lake owners & the public about Aquatic Invasive Species (AIS). A motion was made by Tom Johnson to apply for a DNR Lakes grant; motion was seconded by Mary Mahoney. Motion was passed by a vote of 16 for; 0 against. Deadline for grant application is February 2009. Volunteers to help write the grant were Tom Johnson, Barb Johnson, Mary Mahoney, Bev Robinson and Myrna Donovan.

## News from the Lake

### Grant Application

A grant application was developed and submitted to the DNR per the vote of the members at the meeting of August 30, 2008. The grant was submitted in January 2009 for: AIS **EDUCATION AND MONITORING PROJECT** from the Aquatic Invasive Species Control Grant program. The **Project Goal and Objectives** were as follows:

The goal of this project is to prevent the successful colonization of Eurasian watermilfoil in Red Lake. In support of that goal, the project has three objectives:

1. **Education** : To inform lake users of the threat posed by EWM and teach them the appropriate procedures to prevent its introduction.
2. **Boat Inspection**: To prevent the introduction of EWM by boaters using the public landing.
3. **Lake Monitoring**: To thoroughly survey Red Lake to enable the detection and control of any pre-existing EWM colonies

Unfortunately, the DNR rejected our application and the others submitted from Douglas County. We asked for a total of \$3,300 from the DNR with our lake association contributing another \$1,100 for boat inspection at the boat landing. The Minong Flowage and Cranberry Lake did get \$50,000 for control of Milfoil on those bodies of water.

If anyone would like a copy of the grant, please contact Tom Mahoney or Tom Johnson. We will be re-submitting a revised grant application in August based on advice from Pamela Toshner, DNR Lakes coordinator.

The Town of Wascott is considering funding some of the conservation efforts of lake associations throughout Wascott.

### **Opportunity for Douglas County Boat Landing Monitors – ages 14 to 24**

The Douglas County Land & Water Conservation Committee, has announced a stimulus benefit program for northern counties. The program allows CEP (Concentrated Employment Program) to pay youth workers (age 14-24) for 2009 seasonal work.

Dragonfly is offering two plant packages for Red Lake homeowners. Plants will be available at Mahoney's house in mid-June. Date for delivery will be confirmed at the annual meeting. Here are the plant package options:

### 1 - THE COMPLETE WETLAND – plantings for the shoreline

Add some beautiful graminoids to some of our most beautiful wildflowers and you've got the ticket to stable, beautiful shorelands or wet areas that you need no longer mow.

Habitat: Wet Prairie/Marsh/Lake Edge    Height: 24-48"    Full Sun-Part Shade

8 packs 48 plants \$35.00

Wildflower Species: New England Aster, Swamp Aster, Spotted Joe-Pye Weed, Cardinal Flower, Blue Lobelia, Boneset, Marsh Blazing Star, Grass Leaf Goldenrod, Sneezeweed, Flat Top Aster, Sweet Black Eyed Susan, Monkeyflower, Blue Vervain, Ironweed.

Grass Species: Bottlebrush Sedge, Porcupine Sedge, Caterpillar Sedge, Fox Sedge, Sweet Flag, Torrey's Rush, Path Rush, Soft Rush, Wool Grass.

### 2 - THE COMPLETE PRAIRIE – plantings more than 5 feet away from shoreline

An entire prairie in a single flat. Includes the best prairie grasses and wildflowers combined! Fifty to sixty plants per flat will cover 50 - 120 ft<sup>2</sup>. Free yourself from the oppression of mowing lawn one flat at a time!

Habitat: Dry/Mesic Prairie    Height: 24-60"    Full-Part Sun

8 packs 50-60 plants \$35.00

Wildflower Species: Anise Hyssop, Aromatic Aster, Smooth Aster, Sky Blue Aster, Purple Prairie Clover, False Sunflower, Bergamot, Prairie Coneflower, Yellow Coneflower, Purple Coneflower, Black-eyed Susan, Prairie Spiderwort, Stiff Goldenrod, Smooth Penstemon, Culver's Root.

Grass Species: Little Bluestem, Big Bluestem, Side Oats Grama, Indian Grass.
